WARNING! PLEASE READ CAREFULLY

I am the parent and/or legal guardian of the participant, now entering into a program at Oceanside Gymnastics Academy. I recognize that gymnastics activities involve various risks, dangers and hazards, which can result in severe injuries, including but not limited to, sprains, breaks, permanent paralysis or death. I also realize that my child(ren) will be performing and training on all gymnastics apparatus plus various training devices, including the tumble track and trampoline. Being fully aware of these dangers, I hereby give consent for my child(ren) to participate in any and all programs and activities for which they are registered and I ACCEPT ALL RISKS associated with this participation.

I hereby, for myself and my child(ren) and our respective heirs and successors, PROMISE NOT TO SUE AND FOREVER RELEASE AND DISCHARGE

Oceanside Gymnastics and/or its agents from all liability resulting from damages or injuries incurred as a result of participation in Oceanside Gymnastics programs, including those resulting in acts of negligence.

I further agree and acknowledge that:

- 1. The rules and guidelines governing the use of the premises and equipment are solely for that purpose and it remains my sole responsibility to act and govern myself in such a manner as to be responsible for my own safety;
- 2. I am aware of the risks inherent in participating in gymnastics activities and the use of gymnastics premises, facilities and equipment and I assume the risks and waive notice of all conditions, dangers or otherwise relating to or arising out of such use.
- 3. Where applicable and if so required or participating in, I am aware of the risks inherent in helping my child with gymnastics activities and the use of gymnastics premises, facilities and equipment and I assume the risks and waive notice of all conditions, dangers or otherwise relating to or arising out of such use. I am aware that I am not participating in any gymnastics activity but rather helping my child with his/her gymnastics activity.

I further agree to HOLD HARMLESS AND INDEMNIFY "Oceanside Gymnastics" and its agents from any and all actions, claims, demands, losses, judgements or costs of any nature to any third party resulting from my use of the premises and equipment herein and I agree not to make any claims or take any proceedings against any other person, society, corporation or other legal entity who might claim contribution or indemnity from "Oceanside Gymnastics" and/or its agents in respect of matters which are the subject of this Release. I agree that this Release shall bind my heirs, successors, executors, administrators and assigns. I confirm that I am the full age of eighteen years and I have read this Release and understand it.

I CONFIRM THAT I HAVE READ AND UNDERSTAND THIS RELEASE AGREEMENT. I AM AWARE THAT BY SIGNING THIS RELEASE AGREEMENT I AM AGREEING TO ITS TERMS AND WAIVING CERTAIN LEGAL RIGHTS AND THAT OF MY HEIRS, NEXT OF KIN, EXECUTORS, SUCCESSORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES.
